Elmar Duffner elected new president of the Association of the German Furniture

(Verband der Deutschen Möbelindustrie/VDM) has a new president: the general

assembly elected Elmar Duffner to succeed Michael Stiehl during a video conference

Wednesday. 60-year-old Duffner is the Managing Director of Vivonio Furniture GmbH

in Munich and has already acted as the VDM's president from 2008 to 2014. His term

will be three years.

"In my new role, I hope to play a part in better demonstrating to the public the German

furniture industry's high productivity. Our local furniture manufacturers - many of whom are

true hidden champions - offer the highest quality and have shown the utmost resilience

during the coronavirus crisis", said Duffner. He will be paying particular attention to the new

label of origin, started on 1 August, "Möbel Made in Germany", which stands for quality

furniture from German production. "The current industry trend shows that consumers are

thinking more about the significance of the feel-good factor of furniture and interior design.

Aspects like origin, commitment to quality and sustainability are playing a bigger role when

purchasing furniture." Looking beyond the pandemic, Duffner also plans to press ahead with

the industry's export strategy.

"I'm very glad that we'll be working with Elmar Duffner", said VDM Managing Director Jan

Kurth. "He has years of experience in the furniture industry and, in his current position, a 360°

view of nearly the entire industry, which will enhance our association work."



Duffner thanked his predecessor Michael Stiehl for his dedicated efforts during the recent and, through Corona, challenging months. Stiehl has led the presidium of the association since spring on behalf of Axel Schramm and was re-elected vice president on Wednesday. The general assembly sincerely thanked Schramm, who took up the post of VDM president in 2014 and whose office has been held in abeyance since the end of March 2020, for his successful work for the industry. He will continue to be a part of the presidium.

Alongside Michael Stiehl (Rauch Möbelwerke), Leo Lübke (Cor Sitzmöbel) was also elected vice president of the VDM on Wednesday. The other presidium members are Elko Beeg (Sachsenküchen), Ralph Bestgen (Himolla), Dr. Daniel Böllhoff (Gebr. Nehl), Stefan Bornemann (Erpo), Andreas Decker (Möbelwerke A.
