EXITUS VR would like to answer some questions you may have and also share with you some important information:

- All mobile phones and other electronic devices must be placed inside the lockers of Exitus VR. The game relies on your intuition and team work, your phone will not help you here!
- Food or beverages are not permitted inside the VR areas. Do not bring dangerous or hazardous materials onto the premises.
- Any players under the age of 16 must be accompanied by an adult.

VR Game available for multiplayer's:

- Escape the Cosmos: Players must be at least 10 years old.
- Mind Horror & Decomposed: Players must be at least 13 years old.
- Single Player Stations: Players must be at least 7 years old.

Please do not participate in the game if you are under the influence of alcohol or any mind altering substances (or ANY illegal substances) or any other substances that may affect your senses, reflexes or coordination. The operator may refuse service to admit any patrons without any explanation and without refund.

Any damage to the equipment, accessories/furniture or property is forbidden. Those responsible will be fined accordingly.

Players MUST arrive 15 minutes before the reserved time. There are waivers and instructions that must be given. After 15 minutes past your appointment, the operator may refuse to allow you into the VR AREA to launch the game and you will not be refunded.
