Minutes of the 212th Annual Meeting

(For the year ending December 31,2016)
Second Baptist Church
Suffield, Connecticut
January 22, 2017

The 212th Annual Meeting of the Second Baptist Church was called to order by Scott Schneider in the church sanctuary at 11:05am. Scott determined that the requirement of a quorum of church members were present. Scott welcomed everyone in attendance and made sure all in attendance had the Annual Report and the Agenda for the year ending December 31, 2016.

Minutes of the previous (211th) Annual Meeting – Motion was made by Bev Sikes to accept the minutes of the previous Annual Meeting, seconded by Laura Burnaford.

Review of Reports:

Pastor's Report – Pastor Carr thanked Alison Hardy-Dusto (Office - Church Liaison Manager) for all of her hard work putting together the Annual Report. **In Memoriam** – Pastor Carr read through each name on the back cover of Members and Friends who have passed this year and gave a prayer of thanks to God for the blessing of these people.

After discussion it was agreed to amend this Annual Report with a special addendum for Growth and Outreach Ministries.

Christian Education Financial report Bev Sikes asked about a line item in the Financials that had \$483.49 paid to Sue Schneller – Sue clarified that the item was for many different activities for Crafts, Helping Hands, Sunday School and VBS. Agreed for next year items will be classified with the activity. Using the Check Disbursement request form would make this clear for the CE Treasurer.

Financial and Building Ministries:

Scott wanted to insert some special thanks for all of those that serve as financial stewards – Howard Beal for Missions, Lee LaRochelle for Christian Ed and Laura Burnaford for Diaconate as well as the finance committee and trustees.

Collectors Report

Memorial Fund – Gloria also announced her transition from this position (after the meeting Laura and David Burnaford were named as her successor.)

House – Cliff wished to thank each member of this committee who have given of their time and talents and have really stepped up this year providing countless hours and handiwork to keep SBC buildings running.

Audit Report Art Sikes noted that there have not been an audit report submitted the past two years – Art Sikes cited several local organizations that have had issues when there has not been audits. Suggestion and general agreement to have a 2016 audit completed and sent as part of an addendum to this report.

Other Reports

Trustees Report – the following resolutions were presented to the congregation: The Treasurer of the church is authorized to sell immediately upon receipt any securities given to the church. *Moved by Linda Isham and Seconded by David Jones*.

The Trustees shall have general supervision of the funds, securities and investments of the church now owned or held or which shall be owned or held by the church, and any tow trustees shall have the power to sell, assign or transfer to any person or party, any stocks, bonds or other securities which may become the property of the church upon such terms and for such prices as they deem expedient and my sign and execute any such sale, assignment or conveyance. . *Moved by David Jones and Seconded by Art Sikes*.

The Treasurer of the church, with the approval of one other member of the financial sub-committee, shall be authorized to borrow up to \$20.000 for operating expenses if necessary. *Moved by RC Hubbard and Seconded by Peter Das.*

Resolve that the Second Baptist Church of Suffield Connecticut at this regularly called meeting recommends total pastoral compensation in the amount of \$113,045 of which \$32,400 is designated as Value of housing and Utilities. . *Moved by Barry Sisk and Seconded by Linda Isham*.

Treasurer Report – RC Hubbard presented 2016 actual and 2017 budget. Noted that for the first time in several years we ended 2016 with a surplus. Congregation noted that on item 2700 the word investments was misspelled. Motion to accept as amended *Moved by Lucille Miller and Seconded by Blair Childs*.

Election of New Officers and Board Members – Request was made to change the Nominating Committee format to match the new Ministry Structures. Scott put out the call to the congregation to fill the open Vice Moderator position. 2017 Internal Auditor was changed to RC Hubbard, Director of Memorial Funds was changed to VACANT however post meeting it was announced Laura and David Burnaford would fill this role. Under Trustees need to add Karen Santi as treasurer. Fellowship time coordinator change spelling for Becky Tobiasz. House Committee need to remove RC Hubbard and update spelling of Jamie Guilmette. Under Church Staff Relations the third member is Peter Pierzchala not Paula. Also need to add Laura Burnaford to the Music Committee. Under Nominating Committee remove "president" and replace Past Moderator chair Lucille Miller. The report should remove Karen Santi Past President and insert Lucille Miller Past Moderator. Motion to accept as amended *Moved by Cliff Barron and Seconded by Bev Sikes*.

A motion was put forth to accept all the individual annual reports included herein along with the specific amendments for addendums of an Audit Report and Growth and Outreach report. *Moved by Howard Beal and Seconded by Tina Berrien*. Congregational Comments: This meeting took much longer than normal as the reports were not distributed ahead of time. This meeting was moved earlier one week due to scheduling conflicts. Scott reviewed our current by-laws which require an annual meeting in January. Art pointed out having the meeting later such as February causes conflicts with payroll and getting committees started. Every attempt will be made to work on scheduling and getting reports earlier for 2017 and Scott will review with the Council of Ministries for pre-distribution of the reports for next meeting.

Church Organization Structure - the Council of Ministries recommends to adopt this new structure so ask for an extension of the current structure for 12 months while by-laws and constitution can be reviewed and updated to reflect this structure change. A by-laws committee has been identified led by RC Hubbard. Need a vote of the congregation to extend suspension of portions of the bylaws for another 12 months - accept this new structure, establish this by-laws committee tasked with reflecting the Council structure in our bylaws and constitution. *Moved by Lucille Miller and Seconded by David Jones.* Comment: Evelyne Battle wanted to point out that we need to have more communication between groups and to make sure to keep our office staff informed.

Capital Campaign: Two Special Congregational Meetings were held in 2016 to identify the many building and other needs of major expenditures that might be included in a capital campaign – and the end of these second meeting there was a congregational vote to do a joint feasibility study with First church using a organization called Partners for Sacred Places. During the Feasibility Study Pastor Carr reported that "partners" did over 80 interviews which included many town officials – schools staff etc. Pastor Carr and First Church Pastor will be getting preliminary results Feb 7th and expect the full report later in February. How SBC will proceed with a potential Capital Campaign will be determined by these results so more to come.

Green Team Linda Isham commented that the Green team is under Missions and are currently doing a green assessment which includes using environmentally friendly products that have no harm on ecosystems or human health. They will be looking at other "green" initiatives that could save SBC money.

Scott Schneider asked for any closing comments and since there were none asked Pastor Carr to close.

Closing: Pastor Carr asked all to stand and sing Blest Be the Tie that Binds.

Adjourned at 12:25.

Annual Report of the Pastor Thomas G. Carr

Whenever I look back on a year of ministry and mission within our congregation, I am always pleasantly surprised by all that we do trying to be faithful to the Gospel. In the midst of much anxiety and loss in the world at large and many of our personal lives, we continue to seek and work towards the vision of God, expressed in the prophet Isaiah:

"The wolf shall live with the lamb, the leopard shall lie down with the kid, the calf and the lion and the fatling together, and a little child shall lead them.

They will not hurt or destroy on all my holy mountain; for the earth will be full of the knowledge of the Lord as the waters cover the sea."

I think of our response to the devastating hurricane in Puerto Rico, affecting the entire island including hundreds of American Baptist churches, and how we supported our friend from Kyrgyzstan, Ainur (Nora), as she worked to be reunited with her children after 4 years of separation. I think of our monthly commitment to the Soup Kitchen in Springfield and supporting families in Suffield through the Emergency Aid Association and how, more and more we are opening our building to groups in our larger Suffield community. I think of the small things dozens of people do in our congregation to express our care for one another, particularly those in need – physically and financially, emotionally and spiritually. I think of those who volunteer to make sure our building continues to function well, who work in the kitchen for events like the Lenten Breakfasts, potlucks, the Thanksgiving Dinner, who coordinate parts of our weekly worship services, who prod and push and urge us to keep addressing needs inside and outside our congregation. I think of small groups for spiritual growth and education, and our children and youth who bring a fresh spirit to our common life. And I think of all the times we just "hang out" together, usually with some food, to talk, share, listen and be together as a community of faith. All of these common and not so common things we do and are, help make the vision of God's way become more of a reality.

We are anticipating a capital campaign early in 2018 to raise money for improvements to our building in multiple ways, from the steeple and pillars and painting, to making the building even more accessible for everyone. Though a campaign like this may not be a favorite thing for us, it is a necessary one and a joyous one because through it, we recognize that our building is a ministry, a tool of ministry for our congregation and for many important Suffield community-wide groups.

In addition to ministry with you, I have been blessed to be part of several state and nation-wide actions and organizations. This year, I have been involved in creating the American Baptist Churches Creation Justice Network, a network of American Baptist people and congregations committed to the ministry of eco-justice, which is the care of the "natural world" and human justice, which are two-sides of the same coin. This is the first time in 15 years that eco-justice has been lifted up as an important place in our denominational life, and I am blessed to be part of it.

So, I am grateful. Grateful for the amazing staff with whom I work and for you, members and friends of this congregation for the time I have to be with you in this ministry as we seek to be faithful followers of Jesus and his Way. And I am grateful to God for life.

About 800 years ago, the Christian teacher and mystic, Meister Eckhart said, "If the only prayer you ever said was 'Thank you,' that would be enough." Thank you.

Moderator's Report

Although there were many accomplishments by the Council of Ministries (COM) this year; there are two main themes I would like to focus on for the 2017 Moderator's report, since they are not covered elsewhere in this annual report. They are:

Addressing increased church usage resulting from our ministry of encouraging and supporting outside groups to take advantage of our church facilities

Further development and continuing refinement of the COM governance structure.

The mission ministry to use our church building to support external organizations, especially non-profit and charitable groups, has been discussed at length in many Council meetings. In encouraging more outside groups to utilize our building, greater coordination and monitoring are required to accommodate the increased church usage. The upcoming capital campaign will provide building enhancements to attract additional groups to utilize the church as well as providing required church repairs. However, as we have had new groups use the church, we found the existing procedures confusing, inconsistent, and discovered several "gaps" in the process. The Council quickly realized that if we were planning to grow church usage significantly, we needed a more developed and better defined church usage process. To accomplish this objective, the Council sponsored a new team to address not only the existing issues with church usage, but develop a streamlined efficient process to accommodate expanded usage that is clearly articulated to all the stakeholders. The recently created church usage team has been working to talk to outside organizations and begin to establish a church usage policy where consistent rules will be applied to all outside organizations. A problem resolution approach (e.g. locked out of the building, no heat, users misusing or damaging the facilities, etc.) will be developed as well.

This year our church continued to refine the "Council of Ministries" governance structure after the congregation voted to continue with it. However, we have waited to finalize this structure until our constitution and bylaws were revised accordingly. A special task force was established to revise our constitution and bylaws to reflect operating under the council governance. These documents will be available for review soon and then voted on by the congregation to make the COM governance structure permanent.

We are blessed to have a talented and devoted staff and congregation to keep our church healthy and spiritually growing especially in these challenging times. Even as my second year as moderator is coming to a close, I'm still amazed at all the hard work accomplished by so many skilled people behind the scenes.

Finally, and most importantly, I want to thank all the Ministry teams (including the ad hoc teams), Ministry chairs, staff, our pastor Tom, and everyone who has contributed their dedication and hard work for the success of our activities and accomplishments this year.



2017 Audit Report

This year a review was completed of all SBC accounts. With that in mind the accounting of the books has greatly improved compared to previous years. With the majority of transactions happening through the online bill payment system tracking of transactions was much smoother. We still have a large number of accounts at FNBS and this number should be reduced to only have the base of accounts needed. Some of these accounts are not actively being used which would lend them to being merged in the general church account. We also have a few checking accounts that are not earning interest which means the bank is getting the benefit of holding those funds, but we receive nothing in return. If we reduce the number of accounts we hold this will clean up reporting, provide more security to the funds and will allow us to earn interest on the funds held at the bank. One other item I feel we need to review are checks being written to individuals with no memo or note information. This helps identify transactions more effectively. Even with these items I believe that SBC is improving our financial transparency and that we will continue that trend. Thank you for the continued opportunity to serve the church.

Growth and Outreach

Here are the things that we are focusing on to improve communication here at Second Baptist Church.

Sometimes we try to say everything, and ended up communicating very little. We have up dated the Crier format because, often, we accumulate so much information that people don't try to sort through it all. We are working to implement the same ideas in emails and letters we send. If they contain so much information and few bother to read it, they aren't doing what they intend to do. Say less and you'll communicate more.

This means everywhere you're on the internet and various websites. When people visit our website or Facebook page, they are wanting to communicate with us. They are wanting to build a relationship with us. If they get to your website and can't find up-to-date information, it is a missed opportunity. And if they find outdated information, it communicates to them that there must not be anything going on here. So, they move on. This is why during 2017 we updated our website, simplified it, along with increasing our use of Facebook, in addition to the more traditional ways of communication to individuals and larger groups of people.

We believe we have the most important message to communicate in the entire world—the Gospel, God's good news. Our mission for Growth and Outreach is to continue to improve efforts to communicate with as many people as can that Good News of God.

Annual Report of the Diaconate

- 2017 has been a year of challenges for the Diaconate as well as the congregation of Second Baptist Church. Challenges: growing the congregation, providing fellowship funds to members in need, meeting spiritual needs of congregation including preparation and serving of communion.
- Spearheaded by the leadership of the Reverend Thomas Carr we are attracting new participants to our worship services as well as to other church activities. Membership has slowly begun to grow. The members of the Diaconate took an active role in planning for and leading the spiritual growth activities of the congregation. A huge "thank you" to the members of the Diaconate for their dedicated, faithful, and faith-filled service to our congregation. We are also indebted to past members of the Diaconate for their willingness to step in to help serve in various capacities when needed.
- As the congregation moves toward a more volunteer based service model, this change in how the church's needs are met has created many opportunities for service. This was very evident when Cliff Barron, Scott Miller, and Pastor Carr led the men of the church in preparing, cooking, and serving the annual Thanksgiving feast.
- With the help of Congregation Liaison Manager Alison Hardy-Dusto, we scheduled Sunday Morning Worship Leaders and Greeters.
- The Baptismal Mentoring Program was modified in 2016 with the primary instruction occurring during the Sunday School time and mentors doing other activities with their mentees. As one of the culminating activities in the membership process, the Deacons interview each candidate for baptism or other avenues for membership and evaluate the Faith Statements of each candidate. We also supervise the baptisms and welcome new members into the Family of Christ here at Second Baptist Church.
- Through our Fellowship Funds program the Diaconate provided emergency assistance to financially distressed members of the congregation. The Diaconate also contributed funds toward the completion of various projects and services as part of our worship outreach.
- We have sponsored, helped to plan and/or participated in many church events including: Lenten breakfast devotions, the Ash Wednesday and Maundy-Thursday Services, August Sunday mini-services Homecoming Sunday, Thanksgiving Dinner, weeknight Advent worship opportunities, and the Christmas Eve Service of Lessons and Carols. We also began worked with Pastor Carr on a Reflections for Prayer booklet.

It is our hope that in 2018 we will be able to increase our level of assistance to Pastor Carr as together we work to enhance and increase the spiritual aspects of our congregations life together. We are also hopeful that through our activities we will become stronger in our faith and closer to God and to each other!

House Committee

The SBC House Committee continues to support the church by trying to deal with the effects of time and use on our properties. This year, as in past, we have done what we can to keep the buildings running and able to be occupied. Our only limitations, as they have been historically, are time and money. Fortunately, the Trustees saw fit to allocate a portion of our trust income to building repairs. Although not enough to cover all we need to do, it does provide the necessary capital to effect some repairs. In 2017 we were able to use funds allocated to the building maintenance fund to:

Install new windows in the parsonage: building on the work that was performed last year, the first floor windows were replaced.

Install new membrane on the flat roof next to the chapel.

Additionally, 2017 was filled with a host of typical issues including but not limited to:

Repair and painting of some exterior woodwork Numerous toilet related issues Numerous heat related issues Elevator issues Replacement and repair of some of our lighting

Such is the nature of the maintenance of our properties, our work is never done – there will always be something to do yet the House Committee remains committed to the task.

We spent most of 2017 though prepping for the pending capital campaign and our major repairs. Walt Malec has taken the lead on the initiative, getting numerous quotes from various contractors and kicking off our first project - the peeling wallpaper in the hall.

To the members of the House Committee, Walt Malec, Richard Binns, Ted Sheiber, Jamie Guilmette, and Scott Miller, thank you for your dedication and support of our church – you make a difference.

As a reminder, overseeing of the Church properties is now done on an all-volunteer basis – our plates are full. We ask members of the church to be understanding of our time – if you see something, say something and understand that we will get to it as time and budget allows.

Church Staff Relations

The Church Staff Relations Committee (CSRC) was created by merging the Pastoral Relations and Personnel committees. The CSRC attempts to meet quarterly as needed to serve in a liaison role to align the interests of the staff and of the congregation.

One of our ways to support our staff is to make sure that Second Baptist Staff have performance reviews getting feedback on a regular basis. As all part time staff report directly to the Pastor, The Pastor conducted the Staff reviews in September 2017 as this seemed a better time to align with the Program year rather than try to do on a calendar year basis. Representatives from the Diaconate, Church Staff Relations and Moderator conducted a joint review for the Pastor during July 2017. During the Pastoral review we discovered that the pastor was working too many hours and not getting adequate time off – as we discussed solutions we determined to move the Pastors day off to Monday which has seemed to work well from his feedback.

Finance and Church Staff Relations completed a comparative staffing salary survey in August 2017. SBC staff salaries were commiserate with CT church staff salaries. During the salary review it was also suggested if we have excess funds in this year's budget that we give staff a bonus to recognize their significant contribution to our worship and church life while allowing us to keep our base salaries at the recommended levels. SBC had the funds which allowed a bonus for staff to happen in December 2017. We noted the pastor went several years with no increase since his hire date 2013, our request was put forth to align salary for the pastor this year in 2017 at or above the MMBB pastor recommended salary increase which was approved by Council of Ministries.

During 2017 Church Staff participated in discussions with the room use task force. We shared our analysis that SBC staff salaries (excluding the Pastor) are 59% of the 2017 pledge collection which is more than the 50% target recommended by ABCCONN. Historically SBC has exceeded this 50% recommendation for more than 15 years.

The Current staffing levels are at the recommendation of Church Staff Relations (and others) proposed in May 2014. With SBC staffing remaining constant during 2017 we thank every staff member for their continued contributions to Second Baptist.

CHURCH HISTORY 2017

The congregation of the Second Baptist Church of Suffield accomplished a great deal to fulfill its mission in 2017. Pastoral and lay leadership, staff, and many others enabled programs, building maintenance, financial stability, and the spiritual life of the congregation to be sustained. The temporary church governance plan was continued through 2017 while the church Constitution and Bylaws Revision Team worked to provide a permanent governance plan. A plan was completed in December for presentation to the Council of Ministries in January, 2018. The congregation continued to provide space for many community groups for their programs. The Congregational Liaison Manager, Alison Hardy-Dusto, ran a very efficient office (a "nerve center").

Church programs and activities worked well overall; a few areas need to be functionally improved. The revised Constitution and Bylaws should provide clear guidance for all ministries once approved by the Council of Ministries and the Congregation. The temporary governance plan for 2017 consisted of the Council of Ministries with seven divisions: Worship, Fellowship and Caring, Mission Service and Justice, Spiritual Formation, Financial and Building, Growth and Outreach, and Administrative. All of the functions of the former boards, committees, activities and positions were under one of the seven divisions.

SBC meetings occurred at varied frequencies. During the program year, the choirs, Fabulous Friday Folders, Helping Hands, Great Courses most Wednesday mornings, Church School and Adult class occurred weekly. Other activities were scheduled regularly but less frequently: Springfield Soup Kitchen on the second Saturday of each month, Special Needs Fellowship, Folk Group, and Book Discussion Group. The Bylaws Revision Team met irregularly.

Community organizations continued to make significant use of church facilities. Suffield Academy, when in session, met weekly as did the Boy Scouts, AA. and, usually, yoga class. Meeting less often but regularly were the Cub Scouts and Garden Club which meets on the first Monday, October-June. The Suffield Youth Theater met frequently at certain periods of time.

A number of special events took place in January. On the 7th, a Family Night Pot Luck-Lego event was held in Fellowship Hall. Martin Luther King, Jr Holiday observance was held at Third Baptist Church at 4 pm on the 15th. SBC Annual Meeting was held after the morning worship service on the 22nd.

Sunday morning worship, on February 5, was led by Deacon Len Kingsbury who also preached. The Pastor was attending the American Baptist Clergy Colloquium, January 30 to February 5. The theme was what works and what does not work in pastoral ministry. An American Red Cross blood drive was held in Fellowship Hall on the 15th, 1:30 to 6:30 pm. After Sunday morning worship on the 18th, Karen Santi presented her experience with the Energize CT conservation program. At her house, 60- solar panels were installed in a lease arrangement.

March activity began on the 1st with an Ash Wednesday service in the Kneece Chapel at 7 pm. Lenten breakfasts at 8 am began on the 5th and every Sunday thereafter during Lent. Helping Hands meets on Wednesdays for grades 9-12 and Thursdays for grades 6-8 in the afternoon. The Suffield Youth Theater met nine times in Fellowship Hall in the afternoon. Music Appreciation Sunday was observed on the 19th. An Eagle Scout Court of Honor was held at 7 pm on the 21st.

In April, the Suffield Youth Theater met the 3rd-8th in Fellowship Hall. Palm Sunday was the 9th; the Choir sang "Palms, Passion and Alleluias A Suite for Holy Week" with seven musicians. An American Red Cross blood drive was held in Fellowship Hall 1:30-6:30 pm on the 12th. Maundy Thursday was observed with a service at Third Baptist Church at 7:30 pm. Easter Sunrise service at 6 am was held at Sunrise Park and 10 am worship was at Second Baptist. The month ended on a lively note when the Hot Cat Jazz Band played before and during the worship service on the 30th.

May began with the Garden Club meeting on the 1st. An Asset Mapping meeting was held in conjunction with First Congregational Church on the 6th. The purpose was to identify in the community and each congregation resources to support capital campaigns. The Men's Chorus provided the music in the worship service on Mothers Day, the 14th. Beautiful music filled the sanctuary on Sunday, the 21st, at one pm with flutist Tim Macri accompanied by pianist Scott Nicholas and cellist Peter Zay. Tim Macri has played with orchestras in Europe as well as the U.S. During the morning worship service on the 21st, Jamie Guilmette and Brienne Senez were baptized. Suffield Academy held its Baccalaureate Ceremony at 7 pm on the 25th. The Soup Kitchen was post-poned until September.

June began with an all church Asset Mapping informational meeting and Pot Luck supper on the 2nd at 6 pm. A congregational meeting was held after worship on the 4th to "review the status of a capital campaign including the Readiness Study." Trustees Report

It has been the policy of the Trustees to contribute to the operation and mission budgets. The amount is calculated from the 3-year rolling average and 5% of that average. The value of the endowment is that of November 30th of each year. This year, the value is \$3,936,450.39. That is \$422,722.06 above last year and due mainly from the stock market performance. The endowment is managed by Bank of America/US Trusts and American Funds.

The contributions this year are shown in the Treasurer's budget report. During the year, we received a bequest from the Sam Fuller estate for \$16,308.39. And an additional payout of \$20,761.24 from the Voya Class Action Suit. Voya had managed a portion of our endowment in the past.

Treasurer's Report

The attached Financial report contains the 2017 budget, the 2017 Actual and the planned 2018 budget. Along with these figures you will also find a summary of the Checking account in 2017 and the Investment Account balance at the yearend 2017. The money held in the investment account is currently held in a six-month CD and has been earmarked for designated purposes in the future. As of 1/1/2017 there was a starting balance of \$26,013.03 in the investment account and an ending balance of \$60,544.61 where we created a new category for capital campaign placeholder. We received capital campaign prepayments with \$22,450 deposited to cd and \$22,350 held in checking as the changing tax laws prompted several donors to make early contributions.

Mission Support (Treasurer of Missions) is funded through the pledges and plate offering. In 2017 we have contributed 10.1% consistent with prior years 2016, 2015, 2014 at 10.1%, 10.1% and 10% respectively. For 2018 we anticipate maintaining 10.1% towards Mission support.

Current Pledge and Plate was slightly lower than budgeted. House repairs were lower than expected during the year so picked up some of the painting and wall papering that were slated for the capital campaign out of current available funds which allowed us to start improvements in December 2017. Trust funds contributed \$554 more than expected due to interest adjustments on the Lamont trust. Trusts will contribute 10% more trust money in 2018 (Approx. \$15,578) due to the positive investment performance this year and the average of the past three years which include increased contributions. 2017 Contributions passed through to trusts include \$9,302.99 from class action settlement from our former investment company and \$16,308.39 insurance proceeds that was bequeathed to Second Baptist.

The finance committee met regularly this year reviewing several issues – requesting upgrade to the office computer system and programs (completed with memorial funds), review our phone system and internet connections as we were experiencing slow performance and dropped calls which resulted in upgrading internet services as their basic service did not meet our business needs. Finance task force met with insurance agent securing competitive insurance quotes and determined to change insurance providers.

A new stock clearing account was set up with Merrill Lynch when it was determined that our current trusts would no longer liquidate stock and send proceeds to Second Baptist. We received one stock transaction in the amount of \$12,689.43.

Having three treasurers helped spread the work. Laurie did an excellent job with the bill paying as bookkeeper and set up all online vendors a second time when the bank changed their system mid-year. Art kept on top of the payroll function and expanded our 1099 database for subject vendors, so all tax forms were submitted before year end at significant savings to processing fees. I maintained QuickBooks with deposits, trust transfers and council of ministry reporting and led the finance team initiatives. I also completed an audit of the 2016 financials as requested at last year's annual meeting.

We have had a positive and productive 2017 – Thank you to the many volunteers that serve SBC.

Finance Team

The finance team participated in meetings with Partners for Sacred Places early in the year as we explored a community wide reach for a possible joint capital campaign with First Church. Partners did a great job gathering interviews from the community with Selectman, Police, Fire, School Administrators, the Academy and Suffield Emergency Aid was very informative. Partners also held a brainstorming session with members of both First Church and Second Baptist which was very energizing. Ultimately the decision was made to pursue separate capital campaigns and Second Baptist will not be hiring an outside consultant as our fundraising goal and the cost to pay for consultant did not make sense for us.

Second Baptist did further capital campaign research led by Laurie Gokey conducting our own Meeting Space survey while another group worked to identify issues that needed to be fixed or improved within the church working closely with House Committee and their ongoing 'list'.

In May, finance decided to pursue a review of our Insurance policies with an agent, Ministry Insured, which provides insurance exclusively for houses of worship using national carriers with high AM Best Ratings. This insurance review was in depth review of our policies coverage and needs so I solicited help from Laura Burnaford drawing on her insurance work experience to participate with Treasurer (Karen Santi) and Moderator (Scott Schneider) for interviews and information gathering. The initial in-person interview questionnaire was two hours where we described the workings of Second Baptist including our structure, finances, staff, Christian education, library, website, Church Community Builder, outside groups that use the church, personnel policies, safe church policies etc. The detail policy review included tour of our 29,023 sq. foot church building room by room - including closets as well as an exterior walk around of the 2,196 sq. ft. parsonage. We gathered information on the value of Musical Instruments with input from Evelyne and Jean including the Austin Organ Opus 2439 purchased in 1965 with replacement value \$592,000 including Historical Society Registration of the organ. We further gathered replacement value of the Bells, Chimes and two of the three grand pianos in the church as we were considering separate insurance riders. By contract we need to carry insurance on the grand piano in the Music room that is on loan. Further information was provided when each section of the church was built and year of the last updates for elevator, electrical, roofing and furnace including the Parsonage. Thank you to the House Committee for their help identifying these dates. We provided seven years of loss runs from our current insurance company which revealed only one water leak claim of \$7,500 during that time. Ministry Insured also offered to be a resource providing updated templates for 'safe church' policy and 'personnel policy' which were shared with appropriate groups. In July a review of the policy coverages and recommendations were presented by Ministry Insured in person to Laura Burnaford, Scott Schneider and Karen Santi. We compared coverage to our current policy at the same time and discovered higher limits with expanded coverage with the new insurance carriers including a new policy Directors and Officers which covers all staff and elected officers of Second Baptist with a combined cost coming in near the same cost of our current policy. It seemed obvious to us to accept the new policies with these expanded coverages with no change in our expense effective August 2017.

With the changing tax laws anticipated in 2018 which is anticipated to limit charitable giving tax deductions we informed the congregation that advance 2018 pledge donations as well as advance Capital Campaign donations would be accepted in 2017. \$50,000 of advance donations were received.

Capital Campaign

Our Doors are Open – Let It Shine!

Second Baptist Church Capital Campaign

The capital campaign to restore, rejuvenate, and renovate the property of Second Baptist Church has been active "behind the scenes" during 2017. In the first half of the year Partners for Sacred Places (a nonprofit organization focused on building the capacity of congregations of historic sacred places to better serve their communities) interviewed members of the congregation and community leaders to assess the needs of the church and community. This study was used to further refine where we would concentrate our attention for the campaign.

A steering committee to oversee the project was formed in the second half of the year and is meeting on a regular basis so that a well-thought, concise campaign can be presented to the church for review and approval. Actions that have been completed include:

- Decision not to use a professional project/campaign manager In today's environment the trend is to pay a predetermined, set amount. This is in contrast to paying a percentage of the actual campaign. If our intent was to have a larger campaign than a campaign manager would be appropriate.
- Initial estimates have the total campaign costing around \$350,000.
- Members of the House Committee have been interviewing contractors and obtaining estimates on the various projects around the church property.

Currently we are not in a position to provide a detailed breakout of the costs of the various projects. However, we know that most expensive undertaking will be the restoration of the dome and the painting of the exterior including the pillars. The range for these projects is \$175,000 - \$200,000. The wide range is due primarily to two factors:

- 1. The variability of the price of gold. A firm cost will be determined at time of restoration at the then current gold price
- 2. The preparation of painting the front pillars can vary between scraping of old paint as needed (less expensive) to complete stripping of paint (more expensive).

We also intend to upgrade some of the entries and bathrooms to make them fully handicapped accessible. A complete list of recommended projects will be shared with the congregation in the next few months so that work on the various projects can be started by mid-2018.
