

## Pet Boarding Agreement

The proprietors and the staff of Bunny Lodge undertake to treat all pets with the utmost care and respect and are committed to the health, welfare, well-being and happiness of our guests.

While the proprietors and their employees will take all reasonable care with respect to cleanliness, hygiene and disinfection procedures, they cannot be held responsible for afflictions by and costs associated with any infectious diseases (including kennel cough) or parasites (such as fleas and worms).

While the proprietors and their employees will take all reasonable care, the owner of a dog will be held totally and solely responsible for any injury or death caused to another dog or person (including all veterinary or medical costs), or any damage caused to the accessories of another pet, while that dog is within the premises of Bunny Lodge.

Female dogs will be be boarded while "in season" without prior discussion with and agreement from the proprietors or their staff. Entire (unneutered) male cats will not be accepted for boarding.

- My dog(s) is/are fully vaccinated against Parvovirus, Hepatitis and Distemper PLUS Kennel Cough comprised of both Parainfluenza and Bordetella bronchiseptica components; within the required time frames for immunity development and retention. **No current vaccinations = no boarding**. My cat(s) is/are fully vaccinated against Calicivirus, feline infectious enteritis (Panleukopenia), and
- Rhinotracheitis (Herpes); within the required time frames for immunity development and retention.

## No current vaccinations = no boarding.

- ☐ I have provided all information concerning pre-existing conditions/special problems or behaviour of my animals and special diets, allergies or medications that may pose a risk to my pet or others.
- ☐ I acknowledge that while the proprietors and their employees will take all reasonable care, they cannot be held responsible for injury, death, loss or damage of any kind that may occur to either my animals or their accessories (eg leads, toys bedding).
- ☐ In the event that an animal is observed to be unwell or becomes injured, I give the proprietors and their employees authority to seek and respond to, at my expense, any and all veterinary attention deemed necessary, including transport costs.
- ☐ I agree that in the event of arrears, the proprietors shall have the right to dispose of the animals, and this shall not release me from liability for any unpaid fees or charges. Abandoned pets disposed of 10 days after due pick-up date if the owner has not contacted Bunny Lodge.
- Any other arrangements notwithstanding, I understand that the proprietors reserve the right to charge for up to 10 days of boarding, including any unused days and late cancellations.
- ☐ Whilst at Bunny Lodge I understand my pet may be photographed and I give permission for him/her to appear on Bunny Lodge's website/Facebook account.
- Unless agreed otherwise, I understand my dog will be included in supervised playgroups during his/her stay at Bunny Lodge.
