APTICLES OF INCORPORATION of

SUPPLE DAES COMBOURNIES UNIT OWNERS ASSOCIATION, INC.

The undersioned incorporator of a corporation organized under the Assembla Non-Stock Corporation Law, Chapter 181, Wisconsin Statutes, hereng adopts the following Articles of Incorporation.

ARTICLE I - NACE

The name of this corporation is Summer Oaks Condominium Unit Owners Association, Inc.; and shall be referred to herein as the Association.

ARTICLE II - PERIOD OF EXISTANCE

The Association shall have perpetual existance unless dissolved pursuant to provisions of the Wisconsin Statutes them in effect.

ARTICLE III - PURPOSE

The Association is organized and shall be operated exclusively for the purpose of the acquisition, construction, management, maintenance and care of Association property.

APTICLE IV - POWERS

To carry out the purposes for which the Association is organized, it shall have the powers granted by Chapter 181 of the Wisconsin Statutes and section 703.15(3), Wisconsin Statutes, as from time to time smended. In conscising these powers, the Association shall smalled and maintain its qualification as a Condominium Management association under section 528, of the Internal Revenue Code, as meaned from time to time.

MESTICLE V - MESERSHIP

There is a single class of members of the Association whose qualifications and rights shall be prescribed by the By-Laws.

ARTICLE VI - BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of Directors. The number, qualifications, manner of election and term of directors shall be prescribed by the By-Laws, provided that to time shall the number of directors authorized be less than times (3); and further provided that the number of directors authorized shall always be an odd number.

ARTICLE XI - AMENDMENTS

These Articles may be amended or repealed and new articles may be adopted at any meeting of the members by a three fourths (3/4) affirmative vote of the total membership; provided the text of any such proposed change was included in the notice of the meeting.
