The aim of the holding company is to further develop the companies under the umbrella of Vivonio over the long term. Synergies are created for the companies within the group by forming for instance purchasing alliances and collaborating on international expansion. Thanks to their product portfolios, the companies within the Vivonio Group have evolved into extremely successful suppliers within their respective market segments.
