All teams should have a copy of the regulations and contact lists but if further copies are required then please request these. Please ensure you a familiar with the regulations.

Please remember that if the scores are level at the end of full time, extra time of 7 ½ minutes each way should be played but as soon as one team scores extra time finishes – ie Golden Goal. If no goal is scored in extra time then the game shall be decided by a penalty stroke barrage.

OVER/

Could I remind home clubs of the need to undertake the following as a matter of urgency.

- Liaise immediately with your opponents regarding the time and venue of your game.
- Liaise with your appointed officials by the Tuesday prior to the game.
- Complete and return your Match Details Confirmation form to the EHA Offices no later than Friday 26th October but as soon as possible. We need this information to inform press contacts and ensure that full details can be included on CEEFAX and our web site – www.hockeyonline.co.uk. Failure to comply with this will lead to a fine!
- Ensure that you follow the match day administration guidelines as laid down in Regulation 7. A matchday programme is mandatory at this stage of the competition.
- In case of bad weather please note the procedures to be followed in Regulation 11.4.
- Ensure you are conversant with the regulations concerning eligibility. Note that teams
 may play no more than 2 players who do not hold an EEC passport during the
 competition. You will be asked to note such players on the matchsheet. (Reg 4.2 refers)

If you are travelling some distance and require overnight accommodation please contact Claire at Choice Hotels on 0208 233 2017 who may be able to assist you.

If you withdraw from the competition please advise the EHA immediately. If this is after 5.00 pm on Friday 2^{nd} November please advise John Chaplin on 01604830673.

Match delegates should be appointed to all matches however should no delegate be available home clubs are reminded of their duties regarding the notification of results. This will mean the result and all goals with time, type of goal and scorer being notified to John Chaplin immediately after the match.
