IV ACCESS REVIEWS - 72 HOUR

FOR HOSPITALS WITHOUT AN ELECTRONIC MEDICAL RECORD

LABELS

For use in hospitals that use paper charts.

Use where patients have IV access that requires review at 72 hours.

Pull the activation tag, place in the patient chart, and tear off after use.

For use in hospital wards without an electronic medical record, helping drive daily reviews of need for a urinary catheter. Place at the bedside or at the foot of the bed - magnetic or adhesive. PATIENT REPOSITIONING

Red flashing light after 30 days indicates container requires changing. Service life of 2 years from first activation. Write on Timertag using dry-erase marker pen.

Before first use, press and hold the button until the lights flash. Product is now activated.

START

Press and hold button until green light flashes three times.

STOP

Press and hold button until red light flashes three times.

TEST

Press button for less than 1 second:

- \cdot Green blink (<1s) = Ready.
- Green light (>1s) = Active.
- Red light = Expired.
- No lights = Expired.

ALERT

Timertags 2-72h: Red light flashes every second for 2h, then once every 10s for 22h.

Timertags 7d-365d: Red light flashes every second for 8h, then once every 10s for 14d.

SHELF LIFE

Product must be activated within 2 years from date of manufacture.

SERVICE LIFE

Timertags work an unlimited number of times from first activation for the following time periods:
