## Chaney Allen Women's Continuum of Care



The Crossroads Center's Chaney Allen Women's Continuum of Care program is designed to provide structured, progressive treatment to substance abusing women, with an emphasis on treating women with dependent children and women of childbearing age. The program is culturally sensitive, integrating evidence based treatment practices. In addition, the program is gender specific with a focus on issues relevant for women such as physical and sexual abuse and parenting.

The program is structured to provide a continuum of care from an initial assessment to the appropriate level of care based on client's needs. This may include individual and group therapy at an outpatient or residential level of care, case management services, structured childcare and psychiatric treatment.

The program is designed to also provide services and activities that impact several cooccurring problems such as child abuse/neglect, trauma issues, chronic health issues, dual disorders, employment and self-sufficiency and home management challenges. The program has collaborative relationships with the Hamilton County Jobs and Family Services (JFS), Hamilton County Justice Center, probation and parole, University of Cincinnati Psychiatric Emergency Services (PES), Central Community Health Board (CCHB), Greater Cincinnati Behavioral Health Services, First Step Home and Anna Louise Inn as well as many others.

### **A woman may not be admitted if:**

- She is going through detoxification.
- She is actively suicidal.
- She has medical needs that exceed facility capabilities.

## Chaney Allen Perinatal / Postpartum Services

The Crossroads Center's Chaney Allen perinatal / Postpartum women's program is designed to provide outpatient and/or residential treatment for women with addictions who are pregnant or have given birth, experienced a miscarriage or had an abortion. The program is culturally sensitive with evidence based treatment practices. In addition, the program is gender specific with a focus on physical and sexual abuse, parenting and relationships relevant to females.

The program provides babysitting services for children ages 5 and under, to provide a continuum of care including assessment, individual and group therapy, case management services structured childcare and medical somatics. The residential unit has provisions for prenatal and postnatal services.

The assessment process is expedited for pregnant clients. A structured referral process provides linkages with pregnancy centers, court and criminal justice systems, the Department of Jobs and Family Services (JFS), community mental health centers, case management agencies and (PES) Psychiatric Emergency Services at the University of Cincinnati Medical Center.

## Admission Criteria

The individual must be pregnant or have given birth, experienced a miscarriage or had an abortion and suffers from an addiction disorder.
