ARTICLES OF INCORPORATION  
OF

SUMMER OAKS CONDOMINIUM UNIT OWNERS ASSOCIATION, INC.

The undersigned incorporator of a corporation organized under the Wisconsin Non-Stock Corporation Law, Chapter 181, Wisconsin Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is Summer Oaks Condominium Unit Owners Association, Inc.; and shall be referred to herein as the Association.

ARTICLE II - PERIOD OF EXISTANCE

The Association shall have perpetual existence unless dissolved pursuant to provisions of the Wisconsin Statutes then in effect.

ARTICLE III - PURPOSE

The Association is organized and shall be operated exclusively for the purpose of the acquisition, construction, management, maintenance and care of Association property.

ARTICLE IV - POWERS

To carry out the purposes for which the Association is organized, it shall have the powers granted by Chapter 181 of the Wisconsin Statutes and section 703.15(3), Wisconsin Statutes, as from time to time amended. In exercising these powers, the Association shall maintain and maintain its qualification as a Condominium Management Association under section 528, of the Internal Revenue Code, as amended from time to time.

ARTICLE V - MEMBERSHIP

There is a single class of members of the Association whose qualifications and rights shall be prescribed by the By-Laws.

ARTICLE VI - BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of Directors. The number, qualifications, manner of election and term of directors shall be prescribed by the By-Laws, provided that at no time shall the number of directors authorized be less than three (3); and further provided that the number of directors authorized shall always be an odd number.

ARTICLE X - DISTRIBUTION OF NET EARNINGS


No part of the net earnings of this Association shall inure to the benefit of or be distributable to any individual; except that the Association shall be authorized and empowered to pay reasonable compensation for services rendered, to make payments and distributions in furtherance of its purposes, and to rebate excess assessments.

ARTICLE XI - AMENDMENTS

These Articles may be amended or repealed and new articles may be adopted at any meeting of the members by a three fourths (3/4) affirmative vote of the total membership; provided the text of any such proposed change was included in the notice of the meeting.
